## 2 About Workspace 2 (IPI Project)

### 2.1 Overview

The Integrated Provider Information (IPI) Project has developed a new Data Collection platform that collects all data and information from the Sector that was previously submitted manually or through the Online Investment Tool (OIT).

The new Data Collection Platform, Workspace 2, is an online secure platform, which will collect data and information from the Sector outside of the ITR and SDR systems.

This new system will benefit the Sector and TEC in a number of ways:

- It's a single secure place to upload data that is not already handled by the SDR or ITR
- Person agnostic – this data collection platform can be accessed by anyone that the provider gives permission to from within their organisation
- Secure online access to reports and summaries
- It reduces the total number of entry points to data submission tools.

### 3 Validation Approach

All Data Collection documents submitted through Workspace 2 will be technically validated to ensure the supplied data complies with the rules outlined in this document. Workspace 2 will return a detailed error report to the Provider Site where the data collection was submitted from. Workspace 2 will not accept the submission of the data collection if any validation errors are found; any errors must be fixed and the data collection re-submitted.

The reason for this approach is that TEC aims to validate as many of the business rules as possible and return all the errors at the same time so that they can be corrected all together, rather than being submitted, rejected, fixed and resubmitted multiple times.

The validation applied at submission includes:

- the data entered within a cell is the expected data type
- if data has been entered in a row, all mandatory data types have been filled in within that row
- the data collection document is one expected to be returned to TEC
- the data does not contain any duplicate rows of data
- the data matches the acceptable ranges for submission (EG dropdown list values have been used where applicable, dates and numbers are within the ranges expected).

It does not cover the following:

- any communication with the TEC around expected values within the data collection documents.

## 4 Common Data Types

### 4.1 Overview

There are a number of data types that are contained in multiple different Data Collection documents. The definitions for these items are described in this section.

### 4.2 Correlation ID

Each data collection provisioned by TEC has a unique identifier (Correlation ID). The Correlation ID is used to identify the data collection when it is submitted to TEC to ensure that it's a valid data collection and that it's been submitted by the correct provider.

#### Validation

1. Must correspond with a valid TEC provisioned Data Collection.
2. Must correspond with the EDUMIS number of the provider site it was submitted from.

### 4.3 National Student Number (NSN)

A unique number issued by the National Student Index that identifies a learner.

#### Validation

1. Must be a number between 1 and 10 characters long.
2. Must not be blank.
3. Must not be a duplicate NSN.

### 4.4 Start Date

The date the learner started their training.

#### Validation

1. Must be in dd/mm/yyyy format.
2. Must not be blank.
3. Must follow the business rules outlined for the data collection.

### 4.5 End Date

The date the learner completed their training.

#### Validation

1. Must be in dd/mm/yyyy format.
2. Must follow the business rules outlined for the data collection.



## 4.6 Anticipated End Date

The date the learner is expected to have completed their training.

### Validation

1. Must be in dd/mm/yyyy format.
2. Must follow the business rules outlined for the data collection.

## 4.7 Date of Birth

The date of birth of the learner.

### Validation

1. Must be in dd/mm/yyyy format (EG: 01051999 will not be accepted, must be 01/05/1999).
2. Must not be blank.
3. Must follow the business rules outlined for the data collection.

The gender of the learner.
